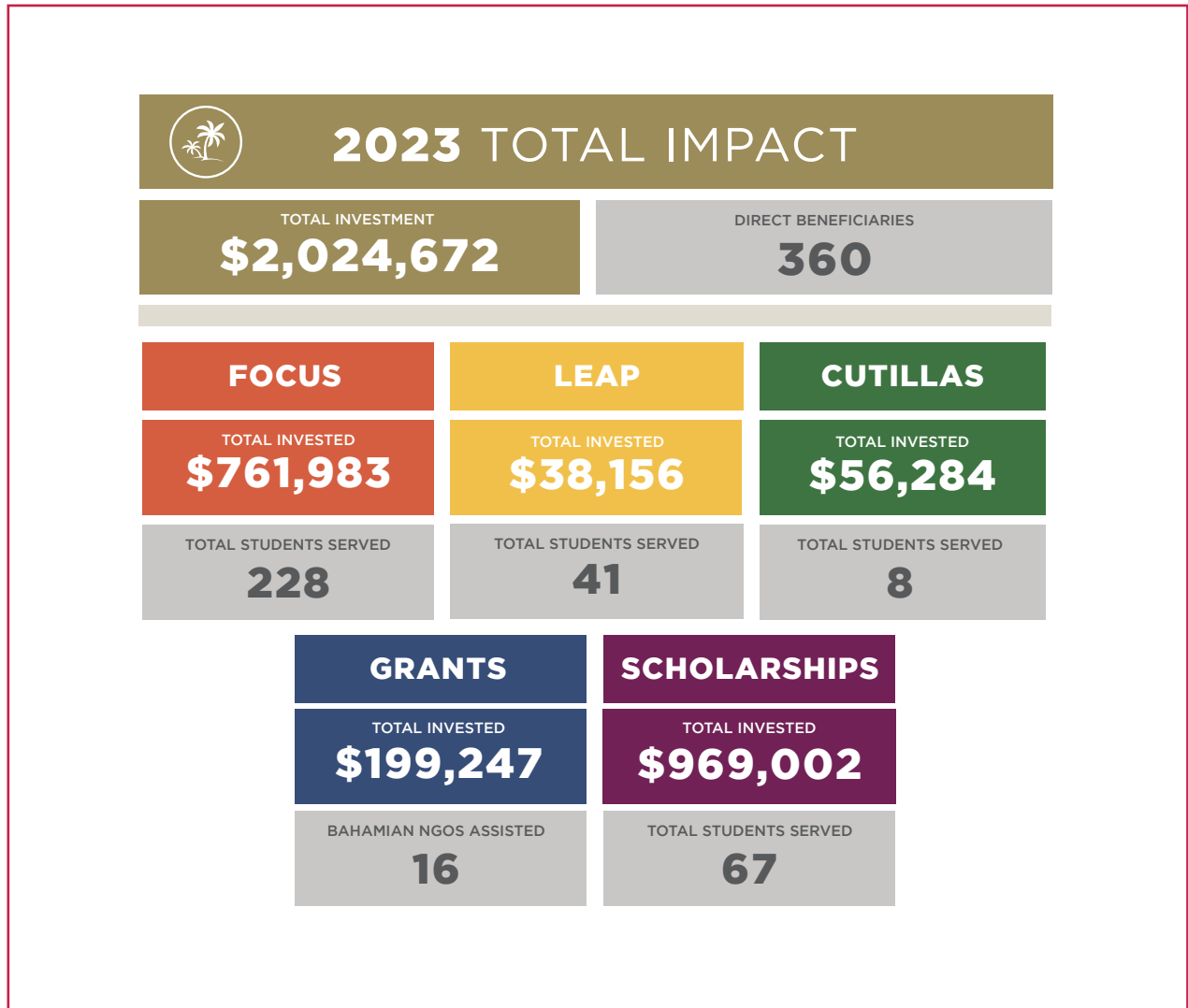
Inspiring the Climb to Success

Ultimately, we believe that success is Lyford Cay Foundations' vision: Every Bahamian is empowered to reach his or her full potential.

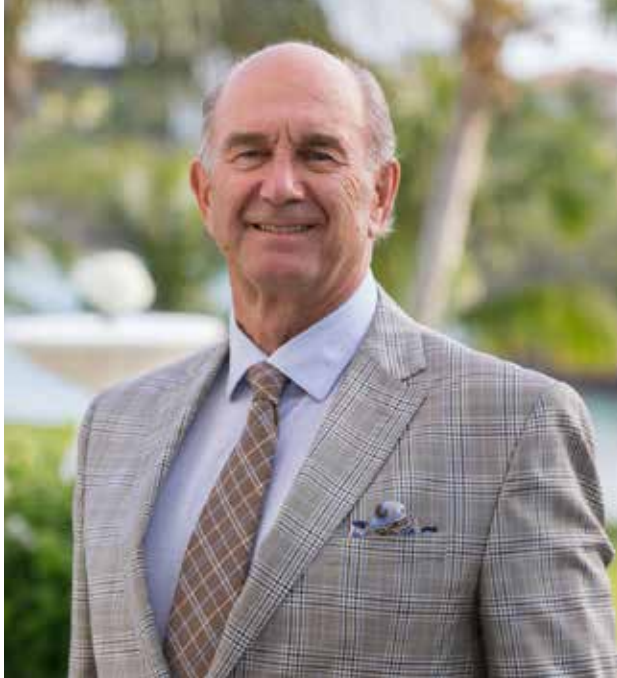

AN INSPIRING LEGACY OF EXCELLENCE & EMPOWERMENT: Tim Unwin



Tim Unwin loved the work of Lyford Cay Foundations and was committed to improving the lives of the people of The Bahamas. He served tirelessly as Board Member of The Canadian Lyford Cay Foundation (CLCF) from 2007, then led the work of CLCF as Chairman from 2017. He stepped down as Chairman in November 2023 but remained an active member until his death on 9th February, 2024.

Mr. Unwin's impact on the Foundations is enduring. He was instrumental in the Foundations' response to Hurricane Dorian – harnessing resources from throughout Canada to help The Bahamas recover. Under his leadership, CLCF raised funds to rebuild the Central Abaco Primary School and to help others in Abaco and Grand Bahama in the immediate aftermath of the storm. Similarly, as the food crisis became evident during the

COVID-19 pandemic, he led the charge for the Foundations to be involved with food relief for those most in need.

Mr. Unwin championed all Lyford Cay Foundations' programmes. He was a strong proponent of Scholarships and understood the value of the opportunities that they provided for young people. He was particularly proud of the quality of Scholarship recipients and the strengthening of the number of scholarships to Canadian universities over the last few years. He was equally supportive of the programmes which helped younger students, including FOCUS, LEAP and The Adelaide Auxiliary's primary school feeding programme. He loved learning about the Foundations' work and knowing about how it changed lives. He visited FOCUS and LEAP as often as he could, introducing other like-minded supporters to the programmes. He enjoyed attending the Annual Holiday Reception and meeting with the beneficiaries of our programmes.

Mr. Unwin was a mentor to the staff of Lyford Cay Foundations. His work ethic and drive were an example to all that met him. He led with compassion and the skill of an advocate, negotiator and mediator.

Most importantly, Mr. Unwin was a family man. He was husband to his beloved, Anne, and a loving father and grandfather. We all observed the joy in his heart from watching his grandchildren grow. Our thoughts and prayers have been with them over these last months and continue to be with them at this very difficult time. They will always be a part of the Lyford Cay Foundations family.

FOCUS



FOCUS is an out-of-school-time, tuition-free enrichment programme for youth in grades 5 through 12. FOCUS provides college readiness and access support to public school students of demonstrated need and potential.

Students begin the programme the summer after 4th grade, with the goal of becoming the first in their family to achieve post-secondary education.

FOCUS provides a unique professional development opportunity for teachers in training. Students are taught by intern teachers, the majority of whom are current education majors at the University of The Bahamas.

2023 Overview

Inspiring A Love of Learning

In 2023, FOCUS continued to provide academic enrichment for students, with special emphasis on literacy, numeracy, and science. Additionally, students were exposed to a wide variety of activities including art classes and sports (swimming, tennis, golf, and soccer), speech, photojournalism, dance, and coding/Lego clubs.

FOCUS' success is based on our long-term commitment to working with students and their parents or guardians until they graduate from high school.

FOCUS helps students address their unfinished learning from their regular school experiences. Through testing, FOCUS teachers identify students who are struggling the most and provide individualised tutoring. Best practices in education, both globally and in The Bahamas, are used to aid learning loss recovery.

The curriculum is guided by The Bahamas Ministry of Education's standards and benchmarks to support what students do in school; this accelerates learning and improves the retention of skills and content. The approach supports students struggling to meet benchmarks and ensures critical intervention when students begin falling behind. For the best outcomes, FOCUS teachers plan lessons based on the Ministry's curriculum, either before or after they are taught in schools, to be used as reinforcement or opportunities for additional mastery.

FOCUS maintained its commitment to a 10:1 student-teacher ratio. Trained teachers provide guidance to our student teacher interns.

Throughout the year, the staff aims to maintain and improve student retention rates and increase interest in learning by delivering personalised experiences. Leaders and interns intentionally foster relationships with students and parents, creating a family atmosphere designed to inspire a love of learning.

SUMMER SLAM

Highlights

With the Summer SLAM theme of “OCEANS”, FOCUS students explored the importance of protecting marine life and the value of ecosystems in various ways. Their marine related field trips included:

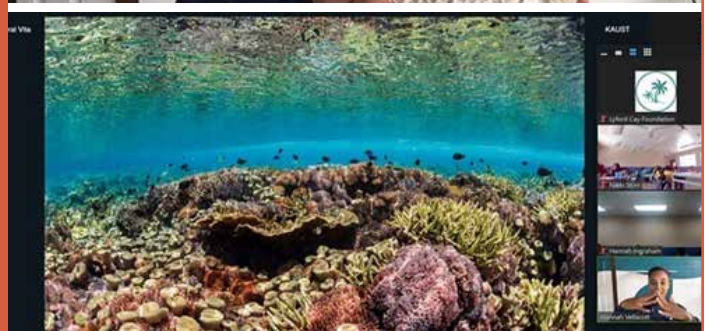
1. Blue Lagoon Island – OCTC students had the opportunity to see and learn about dolphins, seals, sea lions, coral and other marine life residing on site.

2. Bonefish Pond National Park – The students of Grade 9 visited this protected environment, where they learned about various species and had an opportunity to kayak.

3. Royal Bahamas Defence Force – Grade 5 students were exposed to careers related to the ocean at His Majesty’s Coral Harbour Base of The Royal Bahamas Defence Force and toured the major vessels used to protect Bahamian waters.

4. Atlantis Marine Programme – Grades 5 and 6 visited the Atlantis Resort Marine Park and learned how the resort provides education and advocacy for the preservation of marine life and Bahamian ecosystems through the work of the Atlantis Blue Project Foundation.

5. Coral Vita Virtual Field Trip – Students in Grades 7-9 participated in a virtual, interactive presentation by Alannah Vellacott, an inaugural winner of the Royal Foundation’s Earthshot prize.



SUMMER SLAM Highlights

FOCUS students participated in many exciting and educational clubs and competitions. Soccer, swimming, golf, tennis and rowing were among the sports that students explored.



This year, the essay competition centred on conservation. Using information they learned and researched, students wrote and shared their speeches. The competition was stiff and **Eureia Rolle**, a Grade 6 student and Head Girl at Uriah McPhee Primary School was the winner! Here is an excerpt from her speech:

“Deforestation is a big term for cutting down trees. Trees provide oxygen for us to breathe and they reduce flooding. They are homes for organisms and they provide food. You can replant your seed after you are done eating that juicy mango. Because it’s a tree! Planting a tree is just as easy as recycling and stopping pollution.”



Summer Presentations

The 2023 Project Based Learning theme was “Into Orbit: The Exploration of Space and Beyond.”

Students presented their hard work to parents, friends and families at the annual showcase.



2023 On Course To College

On Course To College (OCTC) is the component of FOCUS designed to prepare 10th-12th grade students for the college admissions process.

OCTC students work toward the goal of becoming the first in their families to attend college.

The structured support system that guides their path includes:

- Student support as they work toward obtaining a national diploma and admission into a post-secondary institution.
- Informational sessions that provide an opportunity to interact with college students and learn about college life.
- Coaching to guide them as they compile and write resumes, high school transcripts, college essays and other documents needed for college applications.
- Academic enrichment in a fun and engaging atmosphere to expose students to core concepts in math, science and language needed to achieve the National High School Diploma.
- Service learning so that students dedicate a minimum of 10 hours to a community-focused initiative each summer as global citizens.

Finally, students look forward to Summer Seminar, a series of special sessions for high school seniors which covers several important issues to help them to transition from high school into college and beyond.





LEAP



LEAP (Learning Environment to Accelerate Progress) was created by Lyford Cay Foundations as a response to the findings that pandemic-induced learning loss was particularly serious among the youngest students. The new programme offers a concentrated and exciting way to help even the smallest child make up for lost time with peers and classroom learning.

The programme offers access to three major areas most affected by the absence of interactive classroom activity: social emotional skills, literacy and numeracy.

The pilot programme targeted 41 children from Uriah McPhee Primary School in Nassau who are hosted on the campus of the Lyford Cay International School (LCIS) every Saturday for 10 weeks to boost skills in reading, comprehension, written language and problem-solving in math and numeracy.

Students have the benefit of learning from many of their own teachers and those from LCIS. With transportation, uniforms and a healthy hot breakfast and lunch included, students also develop enhanced social interaction skills to help bridge gaps and build better understanding.

LEAP 2023 Overview

Inspired to take a LEAP



For 4th grader Alexis Sherman, LEAP Saturdays came and went all too quickly.

“I love LEAP. I look forward to seeing my friends on Saturday. I wish LEAP days were longer because it is lots of fun,” she said.

To Alexis, it didn’t matter that she was spending Saturdays learning because her days were full of fun and adventure.

Thanks to an innovative partnership between Lyford Cay Foundations, Uriah McPhee Primary School and Lyford Cay International School (LCIS), a select group of students like Alexis in Grades 1-4 are getting the added academic support that LEAP provides.

LEAP targets 40 children from Uriah McPhee Primary School, which serves one of the most underserved communities in New Providence.

On Saturdays, Alexis is picked up by a bus and driven to Lyford Cay International School where teachers from Uriah McPhee and LCIS spend half a day boosting skills in reading, comprehension, written language

and mathematics. The day begins with breakfast before moving on to circle time which allows students to make a social-emotional connection. Next, students move to their classrooms where they have interactive tutoring lessons. They finish the day with lunch, table-learning time and play.

“Everything about LEAP is great. It helps me a lot. My teacher helps me understand things more. Circle time helps me to feel calm and play time is the best,” Alexis shared.

Alexis’s mother is also a fan of LEAP. “Her reading and spelling have improved,” noted Ms. Shanteria Taylor. “I am truly grateful that I did not have to supply Alexis with any resources for LEAP. The programme provided it all!”

Alexis would like to see LEAP expand. “I think other students who want to come and join would love it.”

Thanks to generous donors, plans to expand LEAP are on the horizon.

Ambassador Frank J Crothers

Inspiring Through Legendary Generosity and Kindness

Ambassador Frank J. Crothers is known for inspiring others with his bright smile, generosity and kindness. As a member of Lyford Cay Foundations Board for nearly 50 years, his philanthropic efforts have made a lasting impact on the lives of thousands of Bahamians.

A Canadian citizen, Ambassador Crothers first came to The Bahamas as a young boy. In time, he became a distinguished private investor, company director and ambassador to The Bahamas from the Sovereign Military Hospitaller Order of St. John of Jerusalem, of Rhodes and of Malta. He is Chairman and Chief Executive Officer of his personal holding company and has served on several boards throughout The Bahamas, the Caribbean, Canada, the United States and South Africa.

While he is well known for his leadership roles with many successful corporations, it is his philanthropic work that has inspired joy and hope for many.

Ambassador Crothers served as a director of the Governor General's Youth Award and was a founding member of the Young Presidents' Organisation. He has been awarded "Chairman's Lifetime Award" from Junior Achievement Bahamas and the "William J. Booth Award" from The Salvation Army. He founded the Bahamas National Feeding Network which has served more than 1.6 million meals to those in need. In recognition of exemplary service, he was awarded the Order of Excellence by the Bahamian government in 2020.

He is deeply committed to Lyford Cay Foundations and was recognised in 2017 by the board for his commitment and dedication. Motivated to see young people excel through education, Ambassador Crothers has always been an avid supporter of the Foundations' initiatives.



Notably, Ambassador Crothers served as Vice President of Lyford Cay Foundation, Inc. and was one of the FOCUS programme's first donors. Over the past three years, he has generously given his support to make the LEAP programme possible.

Along with other Lyford Cay Foundations board members and donors, he was an enthusiastic proponent for the creation of the Harry C. Moore Library and Information Center at the then College of The Bahamas. His support of the library helped ensure that university students have access to tangible educational resources and to thousands of online educational materials.

Cutillas 2022 Scholar Richard Cartwright

Inspired to Dream

Long before Richard Cartwright became a Cutillas Scholar, he and his family recognised education as a pathway to making dreams come true.

The second-year student at the University of The Bahamas was first introduced to Lyford Cay Foundations while he was a fifth grader at Eva Hilton Primary School.

“When my parents heard about FOCUS, they immediately wanted me to apply. They hoped that FOCUS would lead to college, and they knew that we did not have the finances for college,” said Richard.

In FOCUS, Richard eagerly used the various resources offered. He vividly remembers a time when FOCUS played a role in his academic success.

“I did well in English and Biology at C.R. Walker High School, but Math was challenging. The same topics that we were covering in Math class were covered in FOCUS OCTC. It gave me the extra boost I needed.”

Richard worked hard, graduating from high school and from the eight years in FOCUS. He was then accepted into the University of The

Bahamas where he is pursuing a Bachelor of Business Administration in Computer Information Systems. As a Cutillas Scholar, Richard receives the financial support that he needs for tuition and the moral support he needs as a first-generation student. Even as a college student, Richard can still call on the support of his FOCUS family.

Richard understands that pursuing his education takes sacrifice. Using the skills he first learned in FOCUS swimming classes, he works part-time as a lifeguard at a local resort while attending college full-time.

“I work hard now so that I’ll be able to do what I’ve dreamed about. I plan to be an entrepreneur in the tech field,” he said. “With a career like that, I could travel the world.”

As Richard steadily works toward graduation, he gets closer and closer to his dreams every day.

In 2023, Lyford Cay Foundations was pleased to announce the award of a special grant of \$30,000 to Bahamas Technical and Vocational Institute to support The Cutillas Scholarship Awards.

The Cutillas Scholarship Award is named in honour of the late Manuel Cutillas, former Chairman of the Foundations and a strong supporter of technical education.

Students selected for the scholarship are able to complete technical and vocational certification in the Workforce Readiness, Worker Retraining or Dual Enrollment programmes.

Through this new opportunity, the Foundations hopes to support BTVI's efforts to inspire many more students to create bright futures by pursuing exciting technical and vocational education and training pathways.

The grant is a testament to the Foundations' recognition of the important role that technical education plays in empowering Bahamians to reach their full potential.

THE ADELAIDE AUXILIARY

Inspiring Education Through Compassion



The Adelaide Auxiliary was created in the early 1970s by Sir Guy Henderson, a former Chief Justice of The Bahamas, and his wife, Lady Henderson, after observing that some students at Adelaide Primary School did not have enough to eat. The school, that serves approximately 130 students, is in Adelaide Village, a historic but under-resourced community in western New Providence. The original goal of The Auxiliary was to ensure that students had a nourishing lunch daily, enabling them to better focus on their studies.

Nearly 50 years later, this vibrant volunteer-run organisation is still committed to making a difference in the lives of the students. While the food programme continues to be the main priority, the mission has expanded to include several initiatives. Lyford Cay Foundations has proudly supported The Auxiliary's efforts in excess of \$1 million in grants over the past 30 years. Since 2014 The Adelaide Auxiliary has been an agent of The Canadian Lyford Cay Foundation to

further fulfill its charitable mission around the school feeding programme.

School Food Programme

Every day, The Auxiliary serves between 250-350 meals, providing both a hot, nutritious breakfast and lunch for all students. Through the organisation's support, the school now has a paid full-time cook and assistant to meet the students' nutrition needs in a small, well-equipped kitchen. Running the programme is no small feat. It requires the creation of well-balanced menus and the management of food inventory and budgets in light of rising food prices. Most importantly, to ensure that students, some from food-insecure homes, are consistently fed delicious, high-quality food.

Literacy and Education Support Programme

The work of The Adelaide Auxiliary extends beyond the school feeding programme. With some students coming from homes

with both low literacy rates and where English is a second language, The Auxiliary realised that literacy support was needed. Using a sequenced curriculum, 22 volunteers tutor students four times a week. The students have had significant improvements that have been recognised by the Ministry of Education

Beyond literacy, The Auxiliary has provided several educational resources over the years including computer classes and art education. Notably, The Auxiliary funded a dedicated, trained teacher for students with special learning needs.

Sports Programme

Believing that sports are a vital part of a well-rounded educational experience, The Adelaide Auxiliary has partnered with YESI to make soccer lessons available to students. The programme helps instill discipline, high self-esteem and character in each child. The Auxiliary also aids with uniforms, sports shoes, equipment and transportation to and from matches.

Additional Enrichment

Over the years, The Auxiliary has donated on-campus resources, including a pavilion and a playground, giving students access to

outlets for exercise, wellness and fun. In 2023, The Auxiliary conducted an all-day four-week summer programme which served 15 children. Students received tutoring in math and English in the morning and participated in structured fun activities each afternoon. Students have had opportunities to attend numerous field trips, a STEM camp and Camp Bahamas in Eleuthera.

Inspiring global learning and exposure

Can learning go beyond the four walls of the classroom and become a global experience? As evidenced by the Bahamian students participating in World Scholar's Cup, it absolutely can!

With the help of grants from Lyford Cay Foundations totaling \$18,000, student teams from Aquinas College and St. John's College were able to learn, grow academically and socially and showcase their knowledge on an international stage.

The World Scholar's Cup is a global charitable nonprofit initiative for students ages 10-18 of all languages and backgrounds. It aims to inspire in every scholar a love of learning and confidence in new skills, from debate to problem solving. Teams commit to learning a curriculum that covers a wide body of subjects so that they can participate in the academic competition in regional rounds, global rounds and if, they qualify, the final Tournament of Champions at Yale University.

More than 15,000 students from 65 countries participate each year. When the principals of Aquinas College and St. Johns College in New Providence heard about World Scholar's Cup, they knew their students needed to be involved. Teams of motivated students from both schools spent countless hours learning the World Scholar's Cup curriculum in addition to their regular school subjects.

That commitment opened international doors of opportunity. Aquinas College has participated in the competition multiple times, traveling to Barcelona, Spain (2018),

Sydney, Australia (2019) and the Tournament of Champions at Yale University (2019). In 2023, students at Aquinas College and St. John's College qualified for the global rounds in London, England.

"The experience was profound for the students. They were able to travel to a new country, meet new people and compete against some of the best and brightest of the world. These students were able to return and share their journey to the competition with other students and spark an excitement in others," reflected Ms. Junann Lewis, principal of St. John's College.



Both schools received individual and team medals in a variety of categories including debate, writing, social studies and history. The

Aquinas team also qualified for the Tournament of Champions at Yale once again.

For both schools, the impact of participating in World Scholars' Cup has been far reaching. "Students were able to learn beyond the classroom. Our students had a chance to see and experience the world," shared Ms. Shona Moss-Knowles, principal of Aquinas College. "For the students, the experience has been life changing. I've seen their outlooks about what is possible change."

Both schools note that Lyford Cay Foundations' grant was critical to assist with the costly international travel for the teams.

"The funding was a major help to the students," said Moss-Knowles. "We're eternally grateful to the Foundations. I want to say a heartfelt thank you. The support went a long way in terms of the development of young people in this country."

Inspiring joy through needed back-to-school supplies

For most children, a new school year sparks thoughts of colourful backpacks, plentiful school supplies, shiny shoes and crisp school uniforms. These new items are more than just learning tools -- they represent the hope and educational opportunities that a new school year brings.

For those in under-resourced communities, new items for school can be a distant dream. Sadly, the lack of access to school materials can be a barrier to education. Through a \$10,000 Lyford Cay Foundations grant, The Salvation Army was able to inspire more than 200 students from 110 families for the new school year.

Reaching out to families in six low-income neighbourhoods across New Providence, The Salvation Army used the grant to provide school bags, crayons, pencils, pens, pencil cases, notebooks and many other back-to-school supplies. These materials complemented The Salvation Army's Red Shield Education initiative that also provided school uniform vouchers and school shoe vouchers enabling families to purchase the needed items from local stores.

The response from the community was overwhelming, and the joy that was inspired was evident on each face at the distribution drive.

"With rising costs on necessities like food and fuel, families are finding it more difficult than ever to provide back to school essentials," said Major Roodolph Meo, Divisional Commander

for The Salvation Army. "This initiative helps take the pressure off of parents."

Major Meo has seen this pressure in striking ways. "One of the families we helped has five young children, including a set of twins and a newborn. Although both the mother and father work, they can barely make ends meet. Right before the school year started, the husband was in an accident that totaled the family's only vehicle," shared Meo. "They had to use the money they had saved for school supplies to secure transportation. Our initiative helped ensure that the four school-aged children could be ready for school."

"The mother shared that she has almost lost hope and was convinced that her children would not be able to go to school for the first several months. The back-to-school initiative restored her hope," said Meo.

The Salvation Army is renowned for their meaningful work in The Bahamas. In 2020, Lyford Cay Foundations provide over a half million dollars to enable the organisation to provide food assistance to families who were unable to work due to the pandemic. For the past 90 years, The Salvation Army has provided a range of social services for the community.

"We are motivated by our love for God," said Meo. "We want to inspire joy and with the help of Lyford Cay Foundations, we put a smile on many parents' and children's faces."



2023 Holiday Reception

Nearly 200 guests gathered at Lyford Cay Foundations' annual holiday reception at Lyford Cay Club on December 29, 2023. Current Scholars, alumni, grantees, FOCUS students, board members, government officials and donors convened for the much-anticipated celebration.

Basil Goulandris, Chairman of Lyford Cay Foundations, gave opening remarks expressing appreciation for the hard work of the many beneficiaries who have been transformed by the Foundations' programmes and thanking the generous donors who make it possible.

"We are so proud of our legacy of philanthropy," said Mr. Goulandris. "Since we last gathered here, the Foundations has invested over \$2.2 million in programming to benefit Bahamians."

Speakers included Lavano Sands, a first-year medical student at American University of Antigua College of Medicine who credits his formative years in FOCUS, the Foundations' out-of-school-time tuition-free

enrichment programme, for his academic development.

"I am overwhelmed with gratitude and appreciation for FOCUS," shared Sands. "What started as an opportunity has transformed into a profound sense of purpose and understanding. The program didn't just equip me for college; it equipped me for life in its entirety."

Eureia Rolle, Head Girl and Student of the Year nominee for the Uriah McPhee Primary School also read her winning Grade 6 FOCUS competition speech on the importance of caring for the environment.

FOCUS students delighted the attendees with an energetic performance of their motivational chants that start their Saturday sessions.

The annual reception has been a cherished tradition since its launch in 1990 to connect benefactors with beneficiaries.

Inspiring New Opportunities Through Scholarships

Each year, the Foundations receive hundreds of applications for scholarships. The number of applicants continues to grow, demonstrating the high demand for post-secondary education and the need for education assistance.

Twenty-seven new scholarships were awarded in 2023 with 56% of these students being first generation. More than a quarter of the students were from Family Islands.

In total, the Foundations supported 67 students in the 2023-2024 period.

Thanks to caring community partners, two new awards focused on innovation were also available in 2023. These awards will be available for students applying in 2024. The Sir John Templeton Memorial Scholarship was relaunched, creating an award for post-graduate studies in fields that explore themes around human development, human potential and human flourishing. The Nassau Paradise Island Promotion Board Scholarship was created for students pursuing leadership in the tourism industry.

“Lyford Cay Foundations has been a contributor to the development of a prosperous, healthy and peaceful Bahamas through educational opportunities,” said Dr. Nicola Virgill-Rolle. “Innovative leadership in tourism and the development of human potential are both key to the continued progress of the country. We are inspired by these partnerships that will make these new opportunities available to Bahamians.”

With community support, the Foundations continue to prioritise those with the greatest need who demonstrate strong academic potential.

Prince Rahming is the definition of success. The internationally respected Lyford Cay Foundations Alumni Scholar has been Senior Partner at PricewaterhouseCoopers Bahamas (PwC Bahamas) since 2011. His inspiring rise to the top is a tale of hard work, determination and unexpected opportunity.

Prince describes his early years as humble but full of family support. When he was seven, his mother passed away, and he and his siblings moved in with their extended family.

“There were already 15 children in the home. The funds weren’t there, and my options were limited,” said Rahming.

One area that was never limited was Rahming’s academic ability. A bright student, he attended high school at St. Augustine’s College before going on to the College of The Bahamas. Rahming settled on accounting as his major and pursued his Associate degree. As one of the top accounting students at the College, he was awarded a PwC Bahamas scholarship.

The scholarship provided more than funding; it provided an opportunity to network and learn more about the company. The connection solidified his career interest and he applied and was accepted to Acadia University in Nova Scotia, Canada to continue his studies.

While Rahming had the aptitude for university, he did not have funding. He turned to Lyford Cay Foundations.

“When I applied to university, I didn’t have the money,” Rahming said. “My family raised money for me, but I knew that would not be enough.”

“One day the phone rang,” he continued. “It was Lyford Cay Foundations offering me a scholarship. My family and I cried tears of joy.”

With tuition in hand, Rahming was on his way and obtained a Bachelor’s in Business Administration with honours in 1991. He was immediately hired by PwC Bahamas for an entry-level position.

But Rahming's ambitions were far beyond entry-level. "As soon as I walked in the door, I knew I wanted to become Senior Partner," said Rahming.

He spent countless late nights and weekends at work learning from senior members of the firm with this vision in mind. After three years of service, Rahming was selected for PwC's Global Mobility Programme at PwC New York.

"I embraced the opportunity. I visualised my path and gave it my all. After two years in Manhattan, I returned to The Bahamas and was immediately promoted to Audit Manager," said Rahming.

Just a few years later, Rahming was invited to participate in an international exchange that sent him to PwC Switzerland. The programme was slated for eighteen months but Rahming was invited to join the Swiss firm before the end date. In 2006, Rahming was promoted to Director within the Swiss firm and then one year later was admitted into the Swiss partnership.

Rahming's tenure with PwC Switzerland spanned ten years with him consistently achieving along the way. It was at this time that Rahming received an unexpected call for PwC Bahamas offering the position of Senior Partner back in The Bahamas that he had envisioned long ago.

Today, under Rahming's strong leadership, PwC Bahamas has nearly tripled in size.

At the pinnacle of his career, Rahming has not forgotten his roots. "Now my focus is on training the next set of leaders in the firm," mused Rahming.

Rahming counts receiving a Lyford Cay Foundations scholarship as one of the pivotal moments of his illustrious career.

"Donors made a difference for me over 30 years ago and they are still making a difference for so many. Because of your support, I am now doing my best to touch the lives of others."
